

Action Taken Report for clear and Green Campus

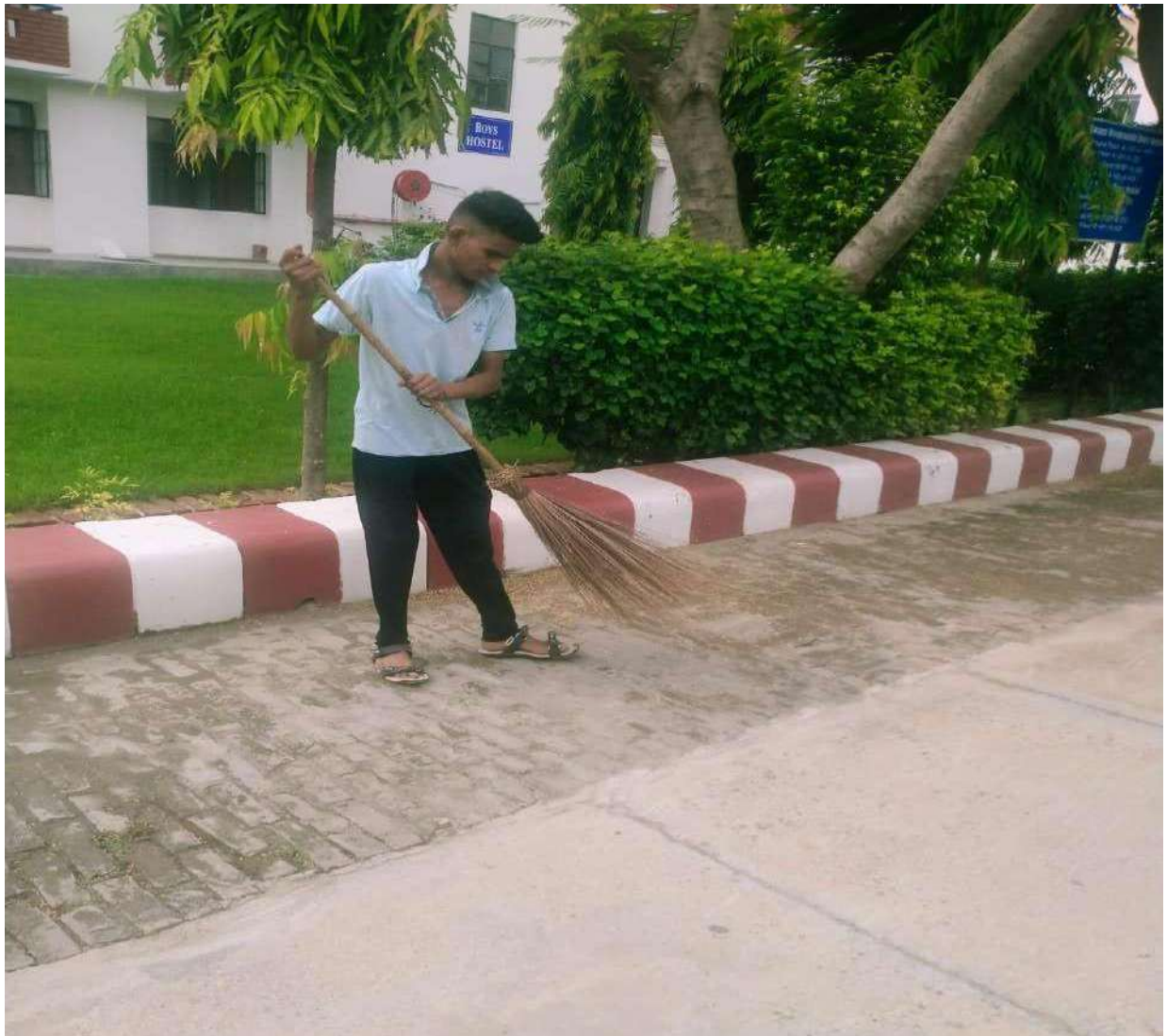

CLEAN CAMPUS INITIATIVES

Nukkad Natak on “Say No to Plastic”

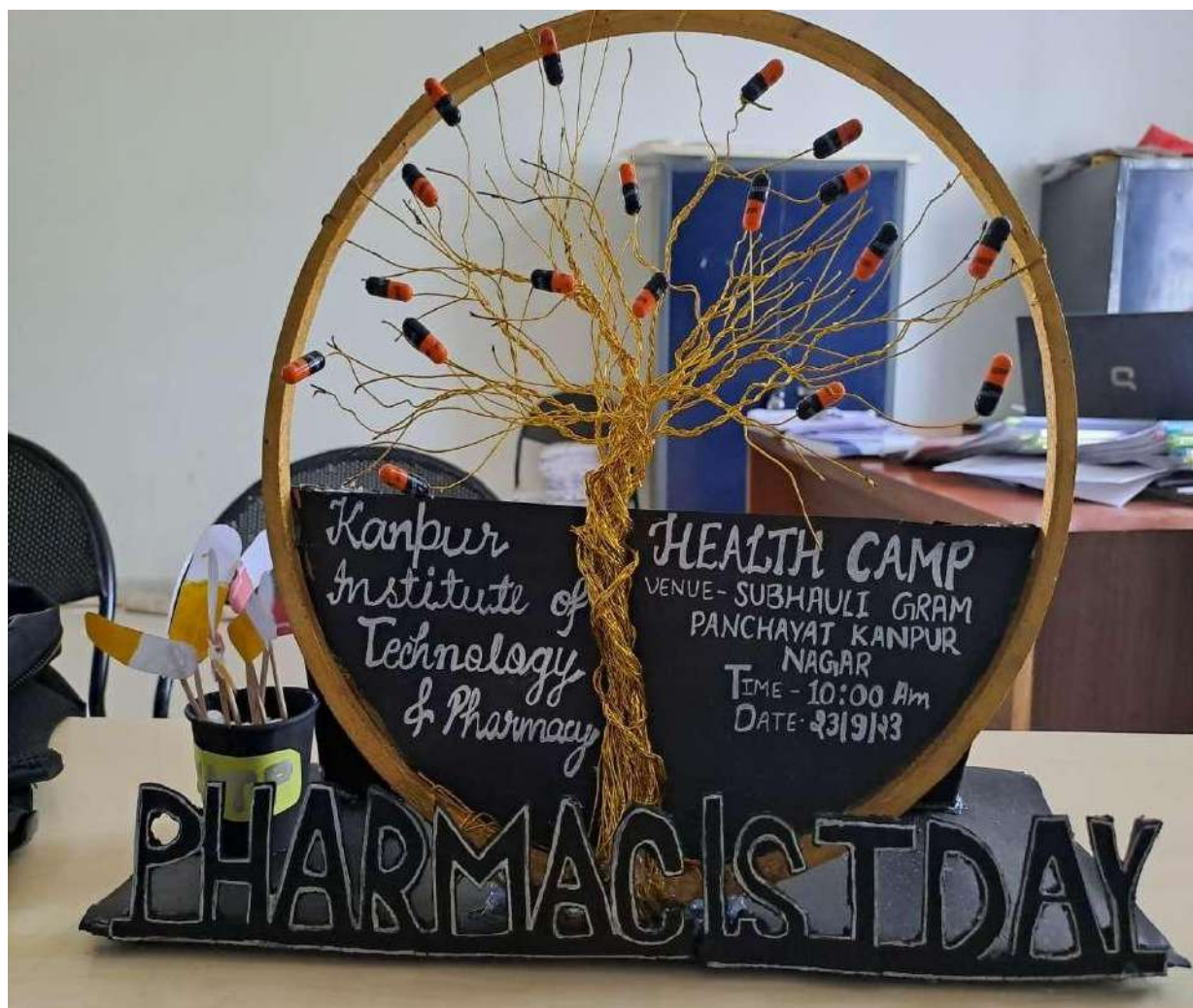

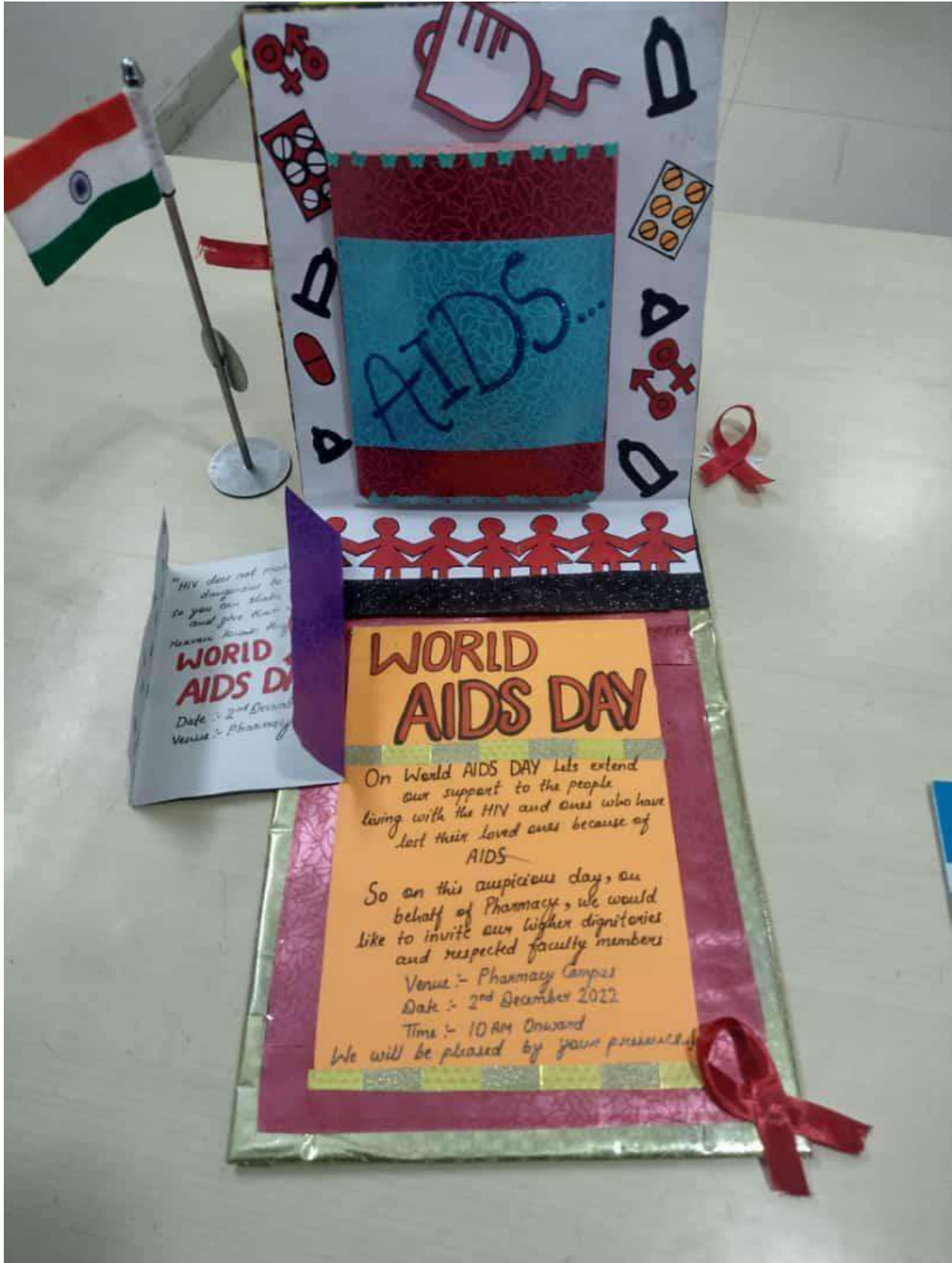




“Best from Waste”

To promote greenery in the campus, KITP regular orgznise Plantation Drives.





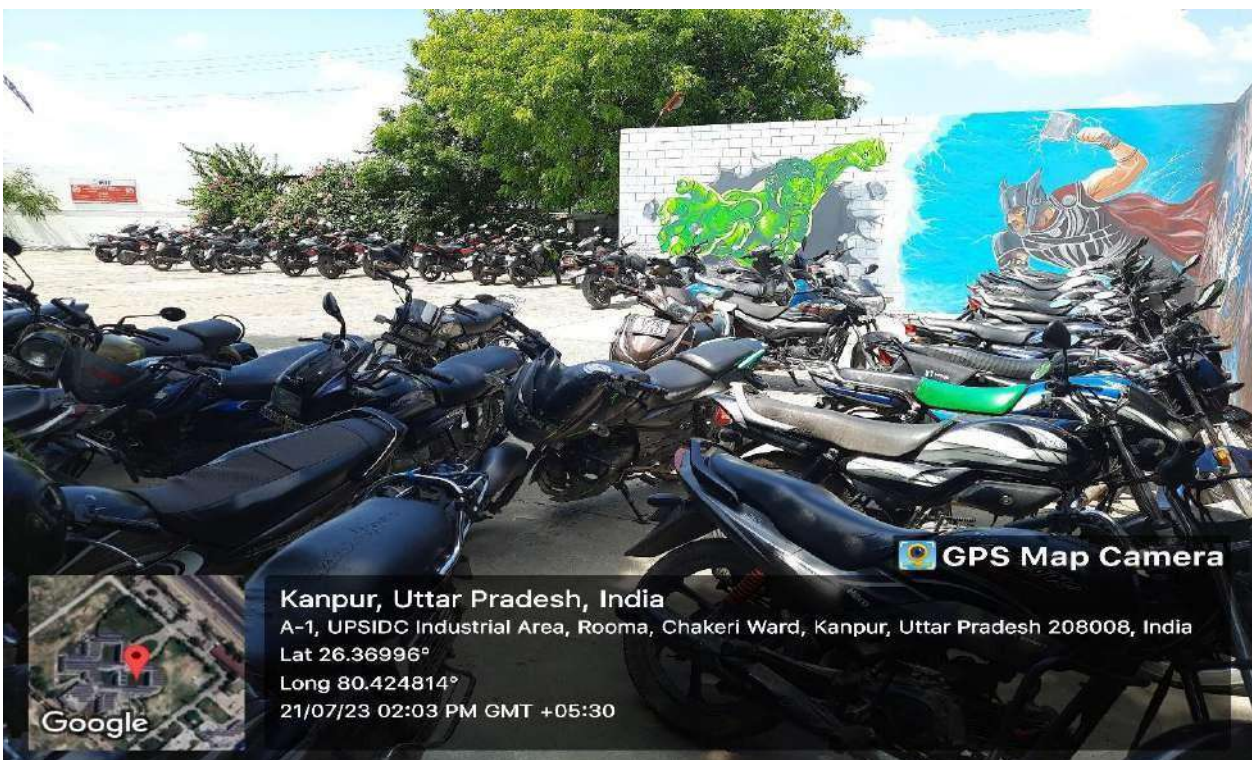






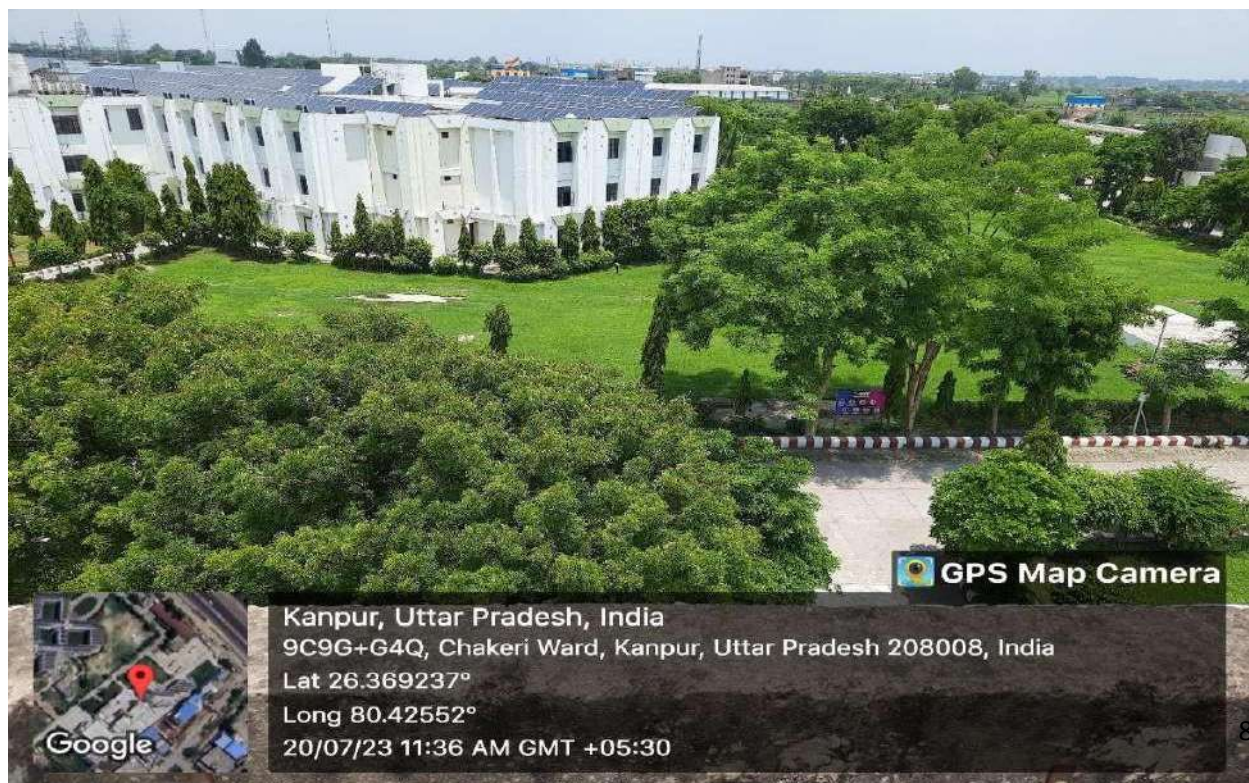
Restricted Use of Automobiles in college campus

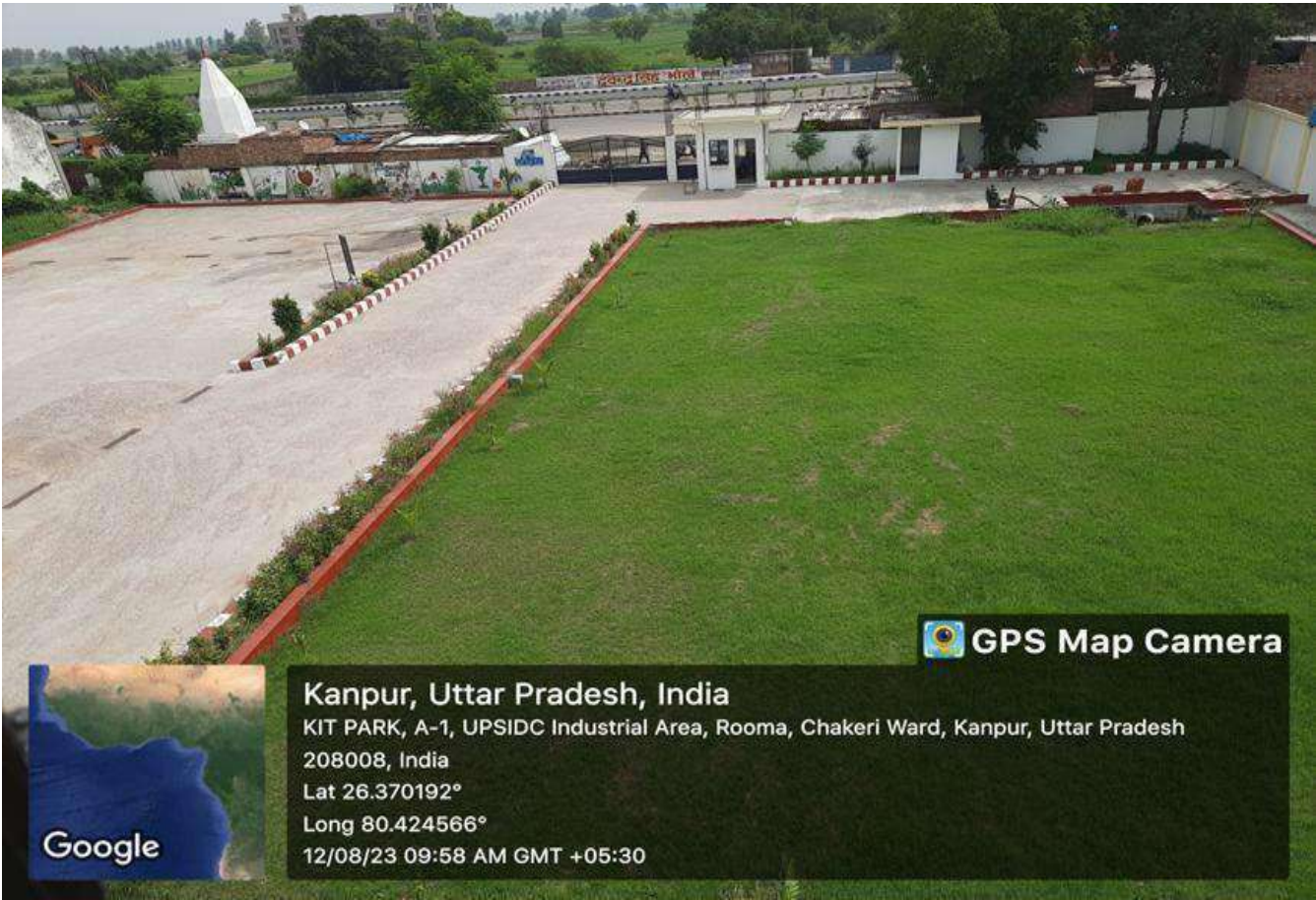
KITP has a strict policy on the usage of automobiles within the college campus. Beyond parking area, vehicles are not allowed to enter the college premise.

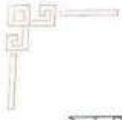
